

CVTE Partnership Program 2024-2025

Goal: Provide dual enrollment vocational exploration for seniors from our sending communities. Upon high school graduation, students would be able to continue training through the CTI (Career Technical Initiative) grant funding or Adult Education programs. Students who elect to continue their training after graduation would earn training hours, industry specific trade certification and be provided job placement assistance upon completion of the entry level program.

Target Population: Seniors from the sending district high schools of Amesbury, Ipswich, Georgetown, Haverhill, Newburyport, Pentucket Regional and Triton Regional.

Program Capacity: We will offer 3 spots for each high school from our sending districts. The maximum capacity is 21 students.

Timeline: Students enrolled will explore the available programs during their senior year for 8 weeks. Students would complete the exploratory program at Whittier from 8am to 11am and would return to their sending schools to complete their academic courses. The proposed start date is Monday, March 17, 2025 and the end date is Friday, May 16, 2025.

Transportation: Enrolled students can use the posted Whittier Tech morning bus routes to arrive at the school. Students will be responsible to arrange transportation to get back to their sending school.

Attendance: Attendance will be communicated daily to the sending schools. Excessive absences will hurt the overall experience for the student and be a disruption to the vocational area. Students with excessive absences may be removed from the program.

Dress Code: Students are expected to report each day in the required dress code. Work Boots are **required** for all programs except Culinary which would require non-slip shoes. Sneakers are also acceptable for Culinary. Hooded sweatshirts and any other clothing with drawstrings are not allowed as they are hazardous when working with machinery and equipment. Students that arrive not dressed properly will not be allowed to participate for the day. On the second offense, they will be removed from the program.

Discipline: Whittier has a strict discipline policy. Students enrolled in the program will be required to agree to our student hand book. If at any time a student violates the student handbook they will be removed from the program.

Adult Education: All of the programs that will be explored will be available for 200 hours of additional career training through the CTI (Career Technical Initiative) grant funding for the students to take during the summer of 2025 at Whittier at no cost.
